

FEEDING GUIDE

Feed to appetite to growing calves up to 6 weeks of age.

When fed prior to weaning, feed in combination with whole milk or milk replacer.

Provide straw or hay as a roughage source to stimulate rumen development.

Ensure fresh, clean drinking water is available.

Follow on by phasing in Barastoc Calf Rearer Pellets, over a 3-day period, from 6 weeks of age.
