FEEDING DIRECTIONS

- Mix with crushed grain at 20% - 30% of the grain part of the diet. Inclusion rate varies according to the protein content of the grain and the desired protein content of the final mix.
- Overall feed rate of the mix varies according to forage availability and quality
- Ensure fresh, clean drinking water is available.
